## Edmonton and Area Corporate Challenge Games 2026

### **Release of Liability, Waiver of Claims and Assumption of Risk**

**\*\*Please read carefully, this document affects your legal rights. By signing this document, you are giving up your right to sue and are agreeing to indemnify Corporate Challenge for claims arising out of your participation in this event.**

I, the undersigned, hereby request permission to enter onto land, facilities or premises and all sponsored event locations to be used in the Edmonton and Area Corporate Challenge (the "Corporate Challenge") for the purpose of engaging in Corporate Challenge sporting and/or leisure activities.

In executing this waiver and release I confirm that my attendance and participation in the Corporate Challenge is voluntary. I also acknowledge that signing this waiver is a pre-condition to my participation in the Corporate Challenge.

#### **A. ASSUMPTION OF RISKS**

I am aware that the Corporate Challenge sporting and/or leisure activities involves such activities as running, jumping, climbing, physical contact, throwing, or rolling an object and involves many foreseeable and unforeseeable inherent risks, hazards and dangers that no amount of care, caution or expertise can eliminate.

I understand and acknowledge that there are risks, dangers and hazards inherent in the sport and leisure activities (the "Risks") which include, without limitation:

- a. Strenuous and demanding physical exertion, movements, exertion and tension on various muscle groups which may cause serious injury to me or my general health and well-being;
- b. Serious bodily injury, permanent disability and death;
- c. Contact with or proximity to other participants, officials, administrators, spectators, natural or manmade objects, dangers arising from adverse weather conditions, imperfect field of play conditions, equipment failure or malfunction, inadequate safety measures and the involvement of participants of varying skill levels;
- d. The failure of other participants to play safely or within the limitations of their own abilities and the negligence of other participants; and
- e. Contact with or exposure to individuals who may have been or may be infected with any virus resulting in me contracting or spreading any said virus.

I am familiar with the facilities, locations or premises in, at or upon which the activities in which I will participate will be conducted, and I know and consent to the risks and dangers involved in such activities including any risks and dangers arising from the use of any and all equipment either I provide or that is provided by Corporate Challenge Members (defined below). I acknowledge that the Corporate Challenge Members or any one of them are not responsible or under any obligation to place any facility, location or premises in any other condition other than what now exists so as to ensure my safety while I am present at that facility.

**I expressly and voluntarily assume the Risks and the responsibility for any damages, liabilities, losses including loss of income, expenses, or any other related losses arising from the Risks as a result of my participation in the Corporate Challenge.**

## **B. RELEASE OF LIABILITY AND WAIVER OF CLAIMS**

In consideration of the permission granted to me to enter upon the aforesaid land, facilities, locations or premises and the privilege of participation in the Corporate Challenge I hereby, for myself and my heirs, executors, administrators, other personal representatives and assigns, **RELEASE, WAIVE, COVENANT NOT TO SUE and DISCHARGE:** (a) The society or other organization incorporated or to be incorporated for purposes of operating the Edmonton and Area Corporate Challenge (the "Society"), and all its members, or shareholders; and (b) sponsors of the Corporate Challenge; and (c) owners and operators of the facilities, locations or premises in, at or upon which activities of the Corporate Challenge will take place; and (d) volunteer workers assisting in the Corporate Challenge activities; and (e) all officers, directors, agents, servants, employees or representatives of the foregoing; (all of which persons are collectively referred to as the "Corporate Challenge Members") **from any and all liabilities, claims, suits, demands, actions and causes of action of any sort INCLUDING ANY CLAIMS ARISING FROM NEGLIGENCE AND GROSS NEGLIGENCE OR ANY FAILURE ON THE PART OF THE CORPORATE CHALLENGE MEMBERS TO SAFEGUARD OR PROTECT ME FROM THE RISK OF** contracting or spreading any virus, for injury sustained by me (including death resulting therefrom), illness or infection and/or property damage of any sort that may be sustained in connection with my participation in the Corporate Challenge in, at or upon such facilities, locations or premises as well as the risk of administering medical aid to me in the event of injury I have incurred while participating in the sport or leisure activity.

## **C. MISCELLANEOUS TERMS**

I agree to participate in the Corporate Challenge on behalf of the named corporation in accordance with all the applicable rules and regulations. I further recognize that I may obtain a copy of the rules and regulations by written request to the Corporate Challenge Games Office at PO Box 67 STN Main, Edmonton, AB T5J 2H5.

If any term, condition or provision of this waiver and release or the application thereof to any person or circumstance shall to any extent be invalid or unenforceable, the remainder of this waiver and release or the application of such term, condition or provision to persons or circumstances other than those as to which it is held invalid or unenforceable, shall not be effected thereby and each term, condition or provision shall be separately valid and enforceable to the fullest extent permitted by law.

The provisions of this waiver and release shall survive my participation in the Corporate Challenge.

I acknowledge that I have reviewed this waiver and release, fully understand its provisions, and I am executing it voluntarily.
